Thank you for your interest in the position of Firefighter/EMT for the City of Bath. Bath is located on the Kennebec River and is well known for its shipbuilding history. The population of 8,408 swells daily with the influx of Bath Iron Works employees. Since 1804, the Bath Fire & Rescue Department has been protecting the City of Ships. There are currently two fire engines, a ladder truck, and three ambulances at the Bath Fire & Rescue Department. The Bath Fire & Rescue Department handles fire calls for Bath with mutual aid to surrounding towns and provides ambulance service for Bath and three surrounding towns. In 2025, we responded to a total of 2,552 calls with 2,065 being EMS. The Bath Fire & Rescue Department has 26 full-time members. Full-time members are represented by Local 1611 I.A.F.F. The City of Bath Fire & Rescue Department welcomes the challenging future and continuously strives to provide the highest quality service to our citizens.

QUALIFICATIONS

Candidates must be legally authorized to work in the United States, have a high school diploma or equivalent G.E.D., and be at least 18 years of age. Candidates must possess a valid driver's license.

Candidates must be in good physical condition and be able to meet or exceed the physical demands outlined in the job description. Applicants are required to pass a preliminary physical agility test as part of the hiring process, and NFPA guidelines require firefighters to undergo annual medical examinations. If a candidate possesses a current Maine AEMT or Paramedic license, the written test will be waived.

Those applying must be of good moral character and must authorize the city to complete a background check, which may include criminal and personal history. History of crime, traffic violations, drug use, and poor work or personal reference responses will affect candidacy.

EXAMINATION STEPS

Include the completion of all application materials, written tests, medical evaluation, interview, thorough background investigation, and a physical agility test. Upon receipt of your completed application material, you will be scheduled to start the examination process for the position. All leading candidates will appear before an Oral Board which will be conducted by the City of Bath's Personnel Service Commission. Leading candidates will receive oral interviews with the

Fire Chief. Details concerning the remainder of the screening process will be provided at that time.

The City of Bath reserves the right to accept or reject any applications that are not completed in their entirety or have misrepresented information.

The City of Ships is currently accepting applications for the position of full-time Firefighter/EMT. Our small, family-friendly city has recently been celebrated as one of the best small cities in America and a distinctive destination by the National Trust for Historic Preservation.

Lateral transfer pay and vacation accumulation are available for candidates with current career Fire/EMS service up to 10 years of experience.

The probationary starting wage for a Basic EMT is \$27.80/hour, for an Advanced EMT is \$28.36/hour, and for a Paramedic is \$31.34/hour. This position is eligible for a generous benefits package including PTO, health insurance, vision insurance, dental insurance, and participation in a two-thirds retirement plan through the Maine State Retirement Program **3C (2/3@ 25yrs.)**. The Bath Fire & Rescue Department is a progressive department that provides an allowance for professional development.

Applicants must currently possess a valid driver's license. The selected candidate must also possess a valid Maine Basic EMT; Advanced EMT; or Paramedic license prior to the job start date and be Firefighter I & II certified. ***Exception to this requirement: if an applicant is licensed as a Paramedic without Firefighter I & II certification, the Paramedic applicant shall be eligible for hire, however, is required to obtain Firefighter I & II level certification within two years of hire date. Additionally, if an applicant possesses a Maine Basic EMT license, the applicant shall be eligible for hire, however, is required to be licensed as an Advanced EMT within two years of hire date.** A copy of your valid driver's license, Maine EMS license, and Firefighter I & II certifications must be attached to your application materials. Leading candidates for this position will be required to successfully pass an in-depth background check and pre-employment (medical) examinations. All candidates will be required to undergo the Bath Fire & Rescue Department physical agility test. A CPAT will not be accepted. Candidates who successfully pass the physical agility test will move on to a written test. **However, if a candidate possesses a current Maine AEMT or Paramedic license, the written test will be waived. The physical agility and written exam will be scheduled. A study guide may be obtained from the City Clerk.**

Interested candidates should apply by submitting ***all*** the following required materials: City of Bath job application, cover letter (addressed to Chief Lawrence A. Renaud Jr.), resume, signed physical agility test liability release, signed statement of physician form, signed background check authorization form, copies of valid driver's license and Maine EMS licensure, and documentation of all applicable certifications and training.

GENERAL PURPOSE:

Protects life and property by performing firefighting, medical aid, hazardous materials operations, and fire prevention duties. Maintains fire equipment, apparatus, and facilities. Performs emergency and non-emergency medical aid activities.

SUPERVISION RECEIVED:

Receives direct supervision from the Captain/Shift Duty Officer, with general direction from the Fire Chief and Deputy Chief.

SUPERVISION EXERCISED:

May help coordinate, instruct, or supervise the work of volunteers or new recruits, as assigned.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Responds to emergency and non-emergency service requests, meets all requirements in accordance with Bath Fire & Rescue Department Standard Operating Guidelines. Requests include, but are not limited to, structural fires, vehicle accidents, hazardous materials spills or releases, forcible entry, alarm investigations, rescue and salvage operations, extrication, water rescues, and burning complaints.
- Responds to emergency medical calls according to Department Standard Operating Guidelines. Performs EMS duties according to licensed level and aids higher license level coworkers as requested
- Conducts fire safety inspections as assigned, cleans and maintains department apparatus, equipment, and property. May be assigned specialized maintenance or repair of department property and equipment. Inspects apparatus and SCBA on a designated schedule. Informs supervisors of any defects or concerns. Performs pre-shift equipment inspection to ensure equipment and personal protective equipment is functional and ready for emergency use.
- Performs duties in a safe manner and reports unsafe activity and conditions to supervisors. Follows department safety procedures, policies, and handbooks.

- Provides written and/or verbal reports as necessary on projects assigned and areas of responsibility. Completes all required documentation and necessary reporting as duties require, including department records management systems.
- Completes project assignments as directed and within required deadlines.
- Acquires and retains a thorough knowledge of the City of Bath, including streets, buildings, water supply, unusual hazards, and related items.
- Cooperates with other departments during emergency incidents, including fire, rescue, law enforcement, and other public safety personnel.
- Participates in the department's employee evaluation process.
- Participates in department training program and classes in firefighting, emergency medical, hazardous materials operations, and related prevention programs; Training for firefighting, medical emergencies, hazardous material operations, and other related topics is an ongoing endeavor that may require on and off-duty participation to maintain a high level of skill
- Presents programs to the community on safety, medical, and fire prevention. Participates in department public service activities such as fire drills, pre-planning assignments, hydrant shoveling burn permits, and extinguisher training.
- Employees are responsible for all other duties as assigned. Essential functions are key components of what the job involves and what is required to perform it. They are not intended to be an exhaustive list of all responsibilities, duties, and skills.

DESIRED MINIMUM QUALIFICATIONS:

Education and Experience:

- High school diploma, GED, or equivalent.
- Firefighter I and II Certification AND Licensed Basic EMT, with ability to become Advanced EMT within two years, , OR
- Licensed Paramedic, with ability to become Firefighter I and II Certified within two years.
- Additional certifications and course work preferred, such as - PHTLS, Paramedic, ACLS, PALS; National Incident Management System (NIMS) courses 100, 200, 700, 800; and other specialized training.

Knowledge, Skills, and Abilities:

- Extensive knowledge of emergency medical aid and resuscitation techniques, protocols, procedures, and equipment.
- Knowledge of modern fire suppression and prevention, hazardous material operations; and related protocols, procedures, techniques, and equipment.
- Skilled in applying emergency medical and firefighting knowledge and techniques in emergency situations.
- Skilled in the operation of apparatus and equipment; ability to learn operation of new fire suppression and other emergency equipment. Ability to perform station maintenance as directed.
- Ability to read and write English; and to follow, give and receive verbal and written instructions.
- Ability to perform work requiring good physical condition, including strenuous or peak physical effort during emergencies or training activities for prolonged periods of time
- Ability to exercise sound judgment in evaluating situations and in making decisions, and to act effectively in emergency and stressful situations.
- Ability to establish and maintain effective working relationships with other employees, supervisors, other agencies, and the public. Ability to follow directives from supervisors, and train and supervise subordinate personnel.
- Possess and maintain a valid driver's license; State of Maine driver's license within one year.

- Must maintain required certifications and become Hazardous Material Ops Certified within 1 year of employment.

ADDITIONAL REQUIREMENTS:

- Must pass Bath Fire & Rescue Department written and physical agility entrance exams and a pre-employment medical evaluation,
- Must pass competence in the department's EVOC training program.

PHYSICAL DEMANDS:

While performing the duties of this job, the employee is frequently required to stand, walk, use hands to fingers, handle or operate objects, tools, or controls, and reach with hands and arms. The employee is also required to sit, climb, balance, stoop, kneel, crouch, crawl, speak, listen, taste and smell. The employee must frequently lift and/or move up to 50 pounds and occasionally lift and/or move over 150 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

Physical surroundings vary with exposure to all conditions, including fire, hazardous chemicals, water, heights, large and small spaces, frequently under demanding and stressful circumstances. Exposure to varying weather conditions including rain, snow, heat, and freezing temperatures, often while wearing PPE or turnout gear. Work may involve an element of personal danger, and employees must be able to act without direct supervision and to exercise independent judgment in meeting emergencies. Work may also involve emotional or distressing situations. High level of physical effort required, such as climbing, bending, standing, and lifting. Regularly uses a desktop computer requiring eye-hand coordination and finger dexterity.

As NFPA guidelines require, employees must undergo an annual physical medical examination. This exam is to be performed by the City's preferred medical provider.

This job description does not constitute an employment agreement and is subject to change.

Physical Agility Liability Release
(Updated January 2024)

I _____, hereby state that I have applied for employment with the Bath Fire & Rescue Department. I understand that the application and hiring process includes a job-related pass/fail physical fitness test consisting of the following activities:

Preparing for the physical agility test. It must be emphasized that regardless of a person's level of fitness, a person should be in good health before beginning any physical training program that emphasizes cardio-respiratory (heart-lung) fitness, strength and muscular endurance, and flexibility. Most people can improve their level of physical fitness through an intensive training program that includes running for cardio-respiratory fitness, weightlifting to develop muscular strength, and stretching exercises to increase flexibility.

How to evaluate your level of physical fitness. From a training standpoint, you should gradually work up to the point where you can run 1.5 miles in 12 minutes or less to establish your cardio-respiratory fitness. Your strength should be gradually developed to where you can do 7 chin-ups, 20 push-ups, and 40 sit-ups with comparative ease. This is about the minimum fitness level for a candidate to safely complete the physical agility test. It must be emphasized that following the guidelines is no guarantee of passing the test. However, your chances of passing will be greatly increased if adequate preparatory physical training has taken place.

What is cardio-respiratory fitness? Cardio-respiratory fitness is the ability of the heart to deliver oxygen to the muscles and other tissues. This is called aerobic power. Simply stated, the ability to perform exercise and/or physical work is directly dependent upon how well the body delivers oxygen to the working muscles. A highly fit person will be able to deliver large amounts of oxygen to the muscles, and therefore be capable of prolonged muscular exercise (for example: fighting fires). On the other hand, the out-of-shape individual will not be capable of delivering adequate amounts of oxygen to the muscles and therefore will become fatigued quickly and be forced to stop working much sooner.

What about muscular strength? Strength can be defined as the ability to apply force. Since nearly all movements are performed against some resistance, a certain degree of muscular strength is needed to perform any activity. Firefighters perform activities against much greater resistance than the average individual. Therefore, the firefighter must have above-average muscular strength, endurance, and power to handle firefighting equipment and perform the duties of a firefighter effectively and safely.

What about flexibility? Flexibility allows the individual to perform required moves without causing injury. Firefighting and many extremely vigorous activities can be performed more safely if the person has good flexibility.

The Physical Agility Test:

Applicants are encouraged to bring their own SCBA mask, turnout coat, firefighter helmet, and either extraction or structural gloves. Applicants must wear pants and closed-toed shoes to the test. If you do not have these items, please contact the Bath Fire Dept at 207-443-5034 prior to the test date to make accommodations.

Do not take the physical agility test lightly. It is more difficult than it appears. Your chances of passing the test will be greatly increased if adequate preparatory training has been undertaken. Physical training should emphasize cardio-respiratory (heart-lung) fitness, strength, and muscular endurance. Running and weight training are two of the best approaches to this end. Prior to the test starting a set of vitals will be obtained, which will entail a blood pressure check and pulse check. Due to the strenuous nature of the test, the Bath Fire Department reserves the right to not allow candidates to run the test based on the vital signs obtained.

Below are descriptions of the six (6) tasks that must be completed in five minutes (5 mins) or less to pass the physical agility test.

Keep in mind that these tasks are performed while wearing a firefighter's coat, helmet, structural firefighting gloves, and a self-contained breathing apparatus (no mask).

The following tasks are not in order of accomplishment for the day of the test and once time passes indicating the start of the test, as a group, all candidates will be walked through the test one time, to be shown the order and expected outcome of each station.

1. Hose Hoist:

Requirement: Hoist 1 ¾ inch fire hose from ground level to the second story which is approximately 16 to 20 feet.

Procedure: Hoist a rolled and tied 50-foot section of 1 ¾ inch fire hose, from the ground level to the second story, and pull hose roll over the rail, and set it onto deck.

Penalty: The candidate will have failed the test if the rope slips through their hands.

Job Relatedness: Firefighters are required to hoist fire hoses and other tools to the upper stories of buildings.

2. Hose Pull:

Requirement: Extend one hundred fifty (150) feet of dry 2 ½" fire hose a minimum of one hundred fifty (150) feet.

Procedure: The applicant will approach one hundred fifty (150) feet of dry 2 ½" fire hose and nozzle, which is in an accordion fold. The hose is placed on the applicant by Fire Department personnel. The applicant CANNOT reach back beyond a six (6) foot mark on the hose. The applicant moves forward until all the hose is extended.

Penalty: The applicant must extend the hose the full one hundred fifty (150') feet or they will have failed the exam.

Job Relatedness: 2 ½" hose is carried on engine companies in lengths up to three hundred fifty (350) feet. A firefighter occupying the nozzle position on an engine company is responsible for extending the line to the point of attack.

3. Ladder Extension:

Requirement: Fully raise (extend) the top (fly) section of an extension ladder and safely lower it completely by using the attached rope (halyard).

Procedure: The applicant will fully raise (extend) and lower the top (fly) section of the fixed extension ladder by using the demonstrated hand-over-hand method; both feet of the applicant must always remain in contact with the ground while raising and lowering the ladder.

Penalty: Allowing the rope (halyard) to slip through the hands in an uncontrolled manner is an unsafe practice and is unacceptable. A ten (10) second penalty will be added to the applicant's total time if the halyard slips and the top section falls three (3) or more rungs. If there is a second slip the candidate will have failed the test.

Job Relatedness: Rescue from elevated levels is sometimes required via ground ladders.

4. Keiser Force Machine:

Requirement: Using a 9-pound short hammer, drive the Keiser Force Machine 5 feet using a controlled chopping motion.

Procedure: The applicant will position their feet appropriately on the Keiser Force Machine. Using the 9 lb. short hammer provided to them, they will strike the Machine and be required to move the Keiser Force Machine 5 feet.

Job Relatedness: To effectively ventilate the roof of a small building, the firefighter would be required to strike the roof a minimum of fifty (50) times, penetrating the roofing materials with each blow.

5. Roof Ladder Forearm Carry:

Requirement: Lift a fourteen (14) ft. roof ladder that is raised against a building, move horizontally by ten (10) feet, then return to the original placement.

Procedure: The applicant will approach a fourteen (14) ft. roof ladder that has been extended and placed on ladder rack attached to a building. Using a forearm carry, the applicant will lift the ladder off the rack and take lateral steps to the right for ten (10) feet. The applicant will then take steps to the left and return ladder to its original position. Ladder must not touch the ground during the carry.

Job Relatedness: This event simulates removing the ladder from the fire truck and placing on the scene.

6. Dummy Drag:

Requirement: Drag 165 lb. dummy 100 feet.

Procedure: The applicant will approach the dummy and proceed to lift and drag the dummy headfirst. The dummy cannot be dragged by the head. No personal devices may be used to drag the dummy. There will be a harness attached to the dummy to assist in dragging. Test time will be stopped once the feet of the dummy cross the finish line.

Penalty: The applicant will have failed the exam if they do not drag the dummy in the manner described above, as demonstrated by the fire department.

7. Claustrophobia Test: This test is a simple pass-or-fail exercise. The candidate shall don a self-contained breathing apparatus face piece and successfully negotiate an established course. If the candidate fails to negotiate the course or needs assistance from the fire department, they will have failed the entire exam.

8. Ladder Climb: The candidate shall climb to the top of the waterway on the aerial ladder that is set at a 60-degree angle. The candidate shall complete this climb in less than four (4) minutes. The candidate must ascend the ladder continually. If the candidate stops for more than ten (10) seconds at any point during the climb or stops more than twice, the entire PAT will be considered a failure. If the candidate fails to complete this climb in the allotted time or if they need assistance from the fire department, they will fail the entire exam.
