In accordance with 30-A MRSA §5772(2-A), the City Treasurer hereby provides the following statement with respect to the City's debt, as of June 30, 2022:

- 1. Bonds outstanding and unpaid: \$22,981,094
- 2. Bonds authorized but unissued: \$321,000
- Additional bonds to be issued the Ordinance is ratified by the voters: \$13,050,000
- Estimated total interest cost on the additional bond: \$5,685,843*
- Estimated total principal and interest cost to maturity on the additional bonds: \$18,735,843

*The amount of interest to be paid will vary depending upon the rate of interest and the years of maturity at the time the additional bonds are issued. The City has assumed an interest rate of 3.0% and a 25-year bond.

The validity of the bonds and of the voters' ratification of the bonds may not be affected by any errors in the estimate made above. If the actual amount of the total debt service for the bond issue varies from the estimate, the ratification by the electors is nevertheless conclusive and the validity of the bond issue is not affected by reason of the variance.
