Sealed Bids addressed to the Municipality of Bath and endorsed on the wrapper "Bids for the Bath, Oak Grove and Judkins Ave Sidewalk Improvements Project in the Municipality of Bath" will be received from contractors at the Bath City Hall located at 55 Front Street, Bath, Maine 04530 at 2:00 P.M., local time March 4, 2021 and at that time and place publicly opened and read. Bids will be accepted from all bidders.

The lowest responsive bidder must have completed, or successfully complete, a Highway, Bridge, or Project Specific prequalification to be considered for the award of this contract.

Description: Federal Aid Project No. SR-2166(500), MaineDOT WIN 21665.00

Location: In Sagadahoc County, project is located along Oak Grove Avenue, Windjammer Way, Judkins Avenue, and Old Brunswick Road in Bath.

Outline of Work: This project includes design of a new sidewalk along Oak Grove Avenue from Congress Ave to Crawford Drive, new sidewalk along Judkins Avenue from Oak Grove Ave to Old Brunswick Road and additional sidewalk work along Old Brunswick Road and Windjammer Way. Work will include construction of sidewalks, sidewalk ramps, landings and crosswalks, related curbing and drainage features, striping improvements, and other incidental work.

The basis of award shall be granted to the responsible bidder whose bid, complying with conditions and requirements provided in this notice and bid form, is the lowest total bid as identified under the Base Bid - Section 0001 form.

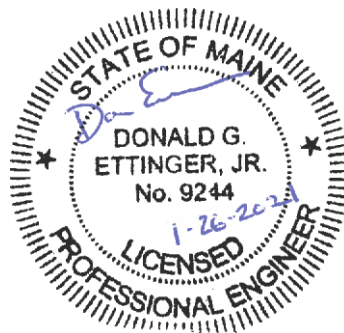
Each Bid must be made upon blank forms provided by the Municipality of Bath and must be accompanied either by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$35,000 payable to Municipality of Bath as a Bid Guaranty. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each for 100 percent of the Contract price, will be required of the successful Bidder.
